

## PRIVACY POLICY

### General Information

The Service is operated by Moldedgear LLC (“MoldedGear”, “we”, “our” or “us”) for users of our Services (you). This Privacy Policy explains what information is collected from visitors and users of our Services and how we use it. We may update this Privacy Policy from time to time to comply with changes in legal, regulatory, or operational requirements. We will provide a notice when such changes are made in accordance with law. With your continued use of our Services you accept those changes.

The controller of personal information in relation to this Privacy Policy is Moldedgear LLC, Melrose Park, IL (USA).

### Security

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure we have put in place suitable physical, electronic, procedures to secure the information we collect online.

### Information we collect

Information you provide us: We collect information from you when you voluntarily provide it to us through the use of our Services. This information includes name, address, email address or phone nr. through the use of our websites.

Data we collect automatically: As a user of our Services we receive and store certain information such as an IP address, geographical location and your activities within our Services.

Cookies: Cookies are small text files with data sent to your computer or device by a website and stored by your browser and can be read for future visits. All essential cookies expire in a year. For more information read our Cookie Settings.

### How we use your information

The information we collect is used in accordance with this Privacy Policy and the information you provide us will be used in relation to the purpose you provided it for. For example, when you sign up to our Services we use your email address to be able to provide you services. ### Disclosure of your information

We are the sole owner of the information collected on this site. We have access to and collect information that you give us. We will use your information to respond to you, regarding the reason you contacted us. MoldedGear will never sell your private information to a third party.

Legal requirements: If required by law we may disclose your information to comply with legal obligations, to protect and defend our rights or property, to protect against legal liability or to protect the personal safety of our users or the public.

#### Children's privacy
